WAIKATO VHF GROUP Inc. TREASURER'S REPORT FOR FINANCIAL YEAR ENDED 31 DECEMBER 2017

2017 was a year of challenges for us. Between Christmas 2016 and New Year, our Te Uku '5675 repeater and links went off the air. Upon visiting the site on 11 January 2017, we discovered our repeater equipment was missing, along with a substantial quantity of other commercial radio equipment from that building we'd been victims of a break-in and burglary! Our group lost a complete radio shelf containing our '5675 repeater plus link terminal facing Te Weraiti along with its associated circulator, load and filter plus interconnecting cables with interfaces. During our site visit, we also discovered water coming down a UHF link feeder (originally donated to us) had filled and badly corroded our UHF duplexer on the end of it. That duplexer was not recoverable, so a replacement was eventually located. Initially, we expected it might be possible to fund replacement equipment (costing approximately \$6000) from a grant similar to that which originally assisted us establish our WaiPlenty repeater network, however tightened requirements imposed on philanthropic agencies mean we no longer qualified. Eventually, a replacement repeater was donated by one of our life members, however the associated link module had to be purchased along with several other ancillary items. Replacing that faulty antenna feeder became a different challenge beyond our means both physically and financially with various consents to be applied for and paid in addition to substantial installation costs. Light appeared at the end of the tunnel when backers of a commercial project planned for that site generously offered to install our feeder along with theirs provided we supplied the materials. That work is expected to proceed at around the time you'll read this, facilitating reinstatement of Te Uku in our WaiPlenty repeater network. Looking back, the cost of funding replacement equipment has been comparable to what it would have cost us over the years to insure that equipment, so we came out around break-even!

We anxiously awaited the outcome of Radio Spectrum Management's 'Review of Licence Fees Framework', following discussions during their 'consultation' stage which indicated amateur 'OA1' radio licence fees could increase by up to 400%. The Waikato VHF Group's submission, along with others from the amateur radio fraternity strongly opposed such an unaffordable increase. When that review's outcome was eventually announced mid 2017, we were relieved to find those amateur **radio licence fees** were to increase by around 8% after discounts we'd previously benefited from were removed. Radio licence fees we paid in 2017 were at the old rate prior to those new fees becoming effective on 1 October last year. Your committee continuously works on **controlling costs**, while membership subscriptions plus donations which together primarily fund our operating costs keep increasing incrementally year on year. In one effort to reduce our overall cost of radio licence fees, the '465 Oto Digipeater was closed down and its licence cancelled during 2017, while the licence for Hamilton's '9725 DMR repeater has been transferred to Branch 12. Repairs and maintenance cost us more last year as a result of costs incurred visiting Maungakawa and Te Uku, plus repairs to Waihi North's repeater. New equipment purchased at discounted rates to reinstate Te Uku shows up as our only capital expenditure for 2017, while some further expenditure will follow in 2018 to bring that site back on.

Donations accounted for 40% of our total income in 2017, and we gratefully acknowledge donations **received in 2017** from ZLs 1AI, 1AMW, 1AOX, 1GWP, 1IC, 1KIP, 1KL, 1KM, 1KRH, 1PR, 1RAB, 1RWR, 1TAJ, 1TEC, 1UJG, 3DM, 3GR and 1FW. Thank you all for your support.

REPORT TO THE MEMBERS OF WAIKATO VHF GROUP INCORPORATED

I have reviewed the financial statements of the Waikato VHF Group Incorporated. The financial statements provide information about the past financial performance and financial position of Waikato VHF Group Incorporated as at 31 December 2017. This information is stated in accordance with the accounting policies set out separately.

The Committee's Responsibilities

The Committee are responsible for the preparation of financial statements which fairly reflect the financial position of the Group as at 31 December 2017, and the results of it's operations for the year ended 31 December 2017.

My Responsibilities

It is my responsibility to express an independent opinion on the financial statements presented by the group, and report my opinion to you.

Basis of Opinion

A review includes examining, on a test basis, evidence relevant to the amounts and disclosures in the financial statements. It also includes assessing:

- The significant estimates and judgements made by the Group in the preparation of the financial statements, and
- Whether the accounting policies are appropriate to the group's circumstances, consistently applied and adequately disclosed.

I conducted my review in accordance with generally accepted accounting standards in New Zealand. I planned and performed my review so as to obtain all the information and explanations which I considered necessary in order to provide me with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatements, whether caused by fraud or error. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the financial statements.

Unqualified Opinion

In my opinion the financial statements fairly reflect the financial position of the Group as at 31 December 2017.
